1. **Deck:** C-15/32 or spaced sheathing **Incline:** Unlimited

**Shingles:** — UL Listed stone coated, direct to deck, non-batten systems.

**Roof Panels:** — Steel, copper or aluminum panels, fastened to 2 x 2 wood battens.

**Shingles:** — UL Classified or Listed Class A asphalt glass fiber shingle.
