Firestone Building Products Company, LLC, an Indiana limited liability company ("Firestone"), warrants to the Building Owner ("Owner") named above that Firestone will, subject to the Terms, Conditions and Limitations set forth below, provide replacement skylight units for any Skylights (as defined below) that leak due to a manufacturing defect during the applicable warranty period.

TERMS, CONDITIONS AND LIMITATIONS

Skylights Covered. The covered skylights are limited to the Firestone provided Sunoptics skylight units and Sunoptics accessories when installed in accordance with manufacturer's specifications on a roof assembled following Firestone's technical specifications by a Firestone-licensed applicator (each, a "Skylight"). Any materials not manufactured or supplied by Firestone are not covered under this Firestone/Sunoptics Skylight Limited Warranty ("Limited Warranty").

Notice. In the event of a leak through a Skylight, the Owner must notify Firestone Warranty Services in writing within thirty (30) days of the occurrence of the leak. By so notifying Firestone, the Owner authorizes Firestone or its designee to investigate the condition of the Skylights at its option. All investigation costs are the responsibility of the Owner.

Limitations. In the event that Firestone determines that the leak is not covered by this Limited Warranty, the Owner's sole and exclusive remedy and Firestone's total liability shall be limited to providing Skylights sufficient to replace the affected units. Should a replacement be necessary, the Owner will be responsible for any costs associated with the removal and replacement of a Skylight. Firestone will use good faith efforts to match the color, size and form of the existing Skylights from Firestone's existing product line but makes no warranty that the replacement Skylights will match. Firestone's replacement obligations over the life of this Limited Warranty are limited to the Owner's original purchase price of the Skylights. The Owner is responsible for completing repairs not covered by this Limited Warranty to be made at the Owner's expense that will permit this Limited Warranty to remain in effect for the unexpired portion of its term. Failure by the Owner to properly make these repairs in a reasonable manner using a Firestone-licensed applicator and within sixty (60) days shall render this Limited Warranty null and void.

Exclusions. Firestone shall have no obligation under this Limited Warranty, or any other liability, now or in the future if a leak is caused by: Hail; Wind; Improper maintenance; Alterations to the Skylights; Condensation and any related water damage that may occur as a natural result of humidity and/or variations between indoor and outdoor temperatures; Failure to comply with applicable standards, codes, recommendations, product specifications or instructions; Breach, rupture or failure of any building envelope component; or, Failure to give proper notice as set forth in paragraph above. Discoloration, fading, chalking and/or yellowing of the Skylights caused by environmental conditions, including but not limited to, weathering, atmospheric conditions, dirt, pollutants, or chemical or biological agents is considered normal aging and is not a manufacturing defect. Minor imperfections and/or variances within plastic materials incorporated into the Skylights that do not affect the performance of the Skylights or blistering, peeling or cracking of the painted finish are not a manufacturing defect.

Transfer. This Limited Warranty shall be transferable and assignable subject to Owner's payment of the current transfer fee set by Firestone.

Products Not Covered. This Limited Warranty only covers Firestone-provided Sunoptics skylights and curbs, and does not cover other products and/or services, including, but not limited to, flashings, seams, adhesives, sealants, coatings, installation or installation workmanship.
